#### **SUMMARY:**

Chippewas of the Thames First Nation is seeking a dedicated and compassionate individual to join our team as a Child & Family Wellbeing Worker. Under the supervision of the Child & Family Wellbeing Services Coordinator, this role is responsible for providing one-on-one support services to children and families involved with Children's Aid Society (CAS), with a focus on holistic family support and wellbeing.

## **Family Support:**

- Develop, coordinate, and deliver support services to children and families.
- Create and implement intervention plans within program guidelines.
- Provide emotional, practical, and advocacy support for families.
- Facilitate programming related to parenting, life skills, and behavior management.
- Conduct monthly home visits and assessments.
- Collaborate with community resources (e.g. mental health, schools, social services).
- Organize community events, including an annual Christmas Party for client families.

### **Recordkeeping & Administration:**

- Maintain detailed and confidential records of client interactions.
- Ensure compliance with reporting procedures and confidentiality standards.
- Submit reports, timesheets, and expenses as required.
