This position plays a key role in delivering high-quality, culturally relevant nursing services to individuals and families in our community. The successful candidate will provide leadership in planning, implementing, and evaluating health programs, with a strong emphasis on health promotion, disease prevention, and holistic wellness.

The CHN Supervisor will work in alignment with the Nation's Comprehensive Community Plan and Community Story, while upholding the high standards required to maintain our accreditation through the Canadian Accreditation Council.

- Coordinate and deliver community health nursing programs through clinic visits, home visits, schools, and public education.
